ORDINANCE NO. 07-114

RELATING TO COUNTY COUNCIL RULES OF PROCEDURE, PROVIDING FOR TELEPHONIC ATTENDANCE AT COUNCIL MEETINGS, AMENDING CHAPTER 2.48 SCC, AND PROVIDING FOR REPEAL

BE IT ORDAINED:

 Section 1. A new section is added to Chapter 2.48 of the Snohomish County Code to read:

2.48.035 Attendance by telephonic means.

- (1) A member of the council may attend and participate in all or part of a council meeting by speakerphone or other form of telephonic communication by means of which the member can hear what is said at the meeting and be heard by other persons attending the meeting. Participation may include voting on any matter before the council. A member who is physically present must preside over the meeting.
 - (2) This section shall not apply to
- (a) a meeting at which a quorum of council members is not physically present at the meeting, or
 - (b) a closed record appeal hearing conducted under SCC 30.72.110.
- (3) A member may attend no more than two council meetings by telephonic means per calendar year. A member who plans to attend a meeting by telephonic means is requested to provide notice at a regular meeting prior to the meeting to be attended by telephonic means. If such notice is not provided the member shall provide reasonable notice to the clerk of the council, who shall be responsible for making necessary arrangements.

Section 2. Snohomish County Code Section 2.48.035, as adopted by this ordinance or hereafter amended, is repealed effective December 31, 2008.
