12 Section 1. Snohomish County Code Section 2.48.170, last amendment by
13 Ordinance No. 12-003 on January 23, 2012, is amended to read:

15 **2.48.170 Council standing committees.**

16 (1) The chairperson shall appoint the members of council standing
17 committees, and for each committee shall designate a committee chairperson.
18 Standing committees are advisory bodies and cannot take final council action
19 within the meaning of RCW 42.30.020(3). Any council member may attend and
20 participate in meetings of standing committees so long as written notice of a
21 special council meeting is given for any special committee meeting attended by
22 three or more council members when council action is taken within the meaning
23 of RCW 42.30.020(3) and written notice of the meeting is required by SCC
24 2.48.030.

25 (2) Meetings of standing committees shall be subject to the requirements
26 of SCC 2.48.030 through 2.48.070, to the extent applicable, provided that any
27 regular meeting may be cancelled by the committee chairperson and the
28 committee chairperson or a majority of the committee may call a special meeting.
29 Regular meetings of standing committees shall be held twice monthly in the
30 Henry M. Jackson Board Room, Robert J. Drewel Building, eighth floor, 3000
31 Rockefeller Avenue, Everett, Washington, at the times stated in subsection (3),
32 except that if any regular meeting falls on a holiday such regular meeting shall be
33 held on the next business day unless cancelled by the committee chairperson or
34 a majority of the committee.

35 (3) The following standing committees and regular meeting times are
36 established:

37 (a) Finance and economic development - second and fourth Tuesday at
38 10:30 a.m.;

39 (b) Law and justice/human services - second and fourth Monday at 1:30
40 p.m.;

41 (c) Operations – ~~((first))~~ second and ~~((third))~~ fourth ~~((Monday))~~ Tuesday at
42 ~~((1:30 p.m.))~~ 9:00 a.m.;


43 (d) Planning and community development - first and third Tuesday at
44 10:30 a.m.;






