1 SNOHOMISH COUNTY COUNCIL 2 Snohomish County, Washington 3 4 ORDINANCE NO. 13-029 5 6 RELATING TO THE SNOHOMISH COUNTY EMPLOYEE 7 WELLNESS PROGRAM AND RE-ENACTING THE PROGRAM 8 9 10 11 WHEREAS, the spiraling costs of health insurance have continued to be of grave 12 concern in the County; and 13 14 WHEREAS, in the 2006 Budget the Executive proposed and Council approved a 15 new Wellness Program to be established representing a medical insurance cost 16 avoidance strategy through a Plan that includes such elements as individual health 17 assessments, targeted personalized plans for reducing risk, lifestyle counseling, 18 monitoring and feedback, flu vaccines, and others; and 19 20 WHEREAS, the program was formally established in 2007 by the adoption of 21 Ordinance 07-060, now called "Partners for Health," creating a new Chapter 3.35 SCC 22 that established an Employee Wellness Program; and 23 24 WHEREAS, Snohomish County Charter 2.115 requires that ordinances 25 establishing programs requiring funding provide for repeal on the date six years 26 following enactment unless re-enacted prior to that date: and 27 28 WHEREAS, SCC 3.35.100 automatically repeals chapter 3.35 SCC unless it is 29 re-enacted prior to August 8, 2013; and 30 WHEREAS, the County Council held a public hearing on May 8, 2013, to solicit 31 32 comments from the public and to consider whether to re-enact chapter 3.35 SCC as set 33 forth in this ordinance; and 34 35 WHEREAS, the Council finds the Wellness Program to be effective in supporting 36 health and wellness for county employees and desires to continue the Wellness 37 Program by re-enacting chapter 3.35 SCC and removing the sunset provision: 38 39 NOW, THEREFORE, BE IT ORDAINED: 40 41 Section 1. Snohomish County Code Chapter 3.35, adopted by Ordinance No. 42 07-060 on August 8, 2007, is re-enacted to read:

The county executive is authorized to create an optional wellness program for county employees to encourage employees to engage in healthy living practices. The program may include health risk assessment, screening, education and similar elements to promote healthy living practices.

Every regular full time and regular part time employee of the county is eligible to participate in the employee wellness program authorized by this chapter, except to the extent such participation is inconsistent with the county's obligations under Chapter 41.56 RCW.
18 19 20 21 22 23 24 25 26 27 28 29 30 31 32 33	3.35.030 Program guidelines and administration.  (1) The employee wellness program authorized by this chapter shall be administered by the director of human resources. On at least an annual basis, the director shall communicate program activities and related incentives to eligible employees.  (2) Participation in the employee wellness program shall be voluntary and no wellness program activity may be included within the official duties of any employee of Snohomish County.  (3) The employee wellness program may reward employee participation in program activities by providing monetary, merchandise, or other incentives based on an employee's level of participation. An employee's receipt of wellness program incentives shall remain contingent upon completion of program activities and upon sufficient budget appropriation for the specific purpose of funding program incentives.  (4) Where a collective bargaining agreement is in effect with respect to particular employees, such agreement shall control to the extent that its provisions conflict with elements of the employee wellness program.
