8 RELATING TO PURCHASES AND CONTRACTS, AUTHORIZING  
9 PURCHASES FROM THE FEDERAL GOVERNMENT, ADDING A NEW SECTION  
10 TO CHAPTER 3.04 SCC AND PROVIDING AN EFFECTIVE DATE

13 WHEREAS, RCW 39.32.090 has since 1945 authorized political subdivisions of  
14 the state to purchase supplies, materials or equipment from the federal government if so  
15 authorized by ordinance or resolution of its legislative body; and  
16

17 WHEREAS, by Section 1, Chapter 132, Laws of 2013, effective July 28, 2013,  
18 the Washington legislature amended RCW 39.32.090 to include electronic data  
19 processing and telecommunication equipment, software and services to the list of items  
20 that may be purchased from the federal government if authorized by appropriate action  
21 of the county legislative body; and  
22

23 WHEREAS, RCW 39.32.090 provides a method for purchases that does not  
24 require the County to call for bids; and  
25

26 WHEREAS, departments of the County have expressed the desire to consider,  
27 from time to time, making purchases from the federal government pursuant to RCW  
28 39.32.090 as amended;

30 NOW, THEREFORE, BE IT ORDAINED:

32 Section 1. A new section is added to Chapter 3.04 of the Snohomish County  
33 Code to read:

35 **3.04.205 Purchases from the federal government.**  
36

37 The county may make purchases of supplies, materials, electronic data  
38 processing and telecommunication equipment, software, services, and/or  
39 equipment from or through the United States without calling for bids, as provided  
40 in RCW 39.32.090.  
41

42 Section 2. Effective date. This ordinance shall take effect on July 29, 2013.


