10 RELATING TO THE REGULATION OF CONSTRUCTION; ADOPTING THE 2012 EDITION
11 OF THE INTERNATIONAL RESIDENTIAL CODE AS REVISED; AND AMENDING AND
12 REPEALING SECTIONS IN CHAPTER 30.52F SCC
13

14 WHEREAS, the merger of the International Conference of Building Officials with other
15 code writing organizations led to the formation of the International Code Council, which led to
16 the creation of a group of international codes that replaced the Uniform Building Codes in
17 2003; and
18

19 WHEREAS, the Washington State Legislature adopted the most current construction
20 codes as the State Building Code pursuant to chapter 19.27 RCW; and
21

22 WHEREAS, the State Building Code Act adopts the International Building, Residential,
23 and Mechanical Codes, as well as the Uniform Plumbing Code and other construction codes;
24 and

25 WHEREAS, the new codes and standards contain updated construction and
26 performance standards, methods, technologies, and products; and
27

28 WHEREAS, the updated version of the State Building Code became effective July 1,
29 2013; and
30

31 WHEREAS, the international and state building codes are updated comprehensively on
32 a three-year cycle; and
33

34 WHEREAS, chapter 19.27 RCW mandates that the State Building Code be
35 administered and enforced by counties and cities, and grants counties and cities limited
36 authority to amend provisions of the State Building Code as it applies within their jurisdictions;
37 and
38

39 WHEREAS, the Snohomish County Council (county council) and the Snohomish
40 County Executive have identified regulation of development to ensure safe and quality
41 construction as a high priority and have delegated the responsibility for administering the State
42 Building Code to Snohomish County Planning and Development Services (PDS); and
43

44 WHEREAS, PDS endeavors to administer and enforce the State Building Code in
45 accordance with chapter 19.27 RCW in order to provide for statewide consistency for the
46 construction industry and the citizens within Snohomish County; and
47

48 WHEREAS, the new international codes contain updated construction and
49 performance standards, methods, technology, and products to improve construction safety
50 and provide greater flexibility to meet minimum standards; and
51

1 WHEREAS, on August 27, 2014, the county council held a public hearing after proper
2 notice heard public testimony related to the proposed code amendments, and considered the
3 entire record; and
4

5 WHEREAS, immediately following the public hearings, the county council deliberated
6 on the proposed code amendments.
7

8 NOW, THEREFORE, BE IT ORDAINED:
9

10 Section 1. The county council makes the following findings:
11

12 A. The foregoing recitals are adopted as findings as set forth in full herein.
13

14 B. The proposal is to amend Snohomish County Code (SCC) title 30.
15

16 C. Procedural requirements.
17

18 1. This ordinance is consistent with state law, chapter 19.27 RCW.
19

20 2. This ordinance is exempt from the State Environmental Policy Act, chapter
21 43.21C RCW ("SEPA"), requirements pursuant to WAC 197-11-800(20).
22

23 3. This ordinance is exempt from planning commission review pursuant to
24 SCC 30.73.040(2)(c) because it implements the State Building Code Act,
25 not the Growth Management Act.
26

27 4. This ordinance does not adopt development regulations under SCC
28 30.10.080. Therefore, notice to the Washington State Department of
29 Commerce (Commerce) of intent to adopt pursuant to RCW 36.70A.106 is
30 not required.
31

32 5. The public participation process used in the adoption of this ordinance has
33 complied with all applicable requirements of the SCC.
34

35 D. This ordinance is consistent with the record.
36

37 1. RCW 19.27.040 allows the governing body of each county and city to
38 amend the State Building Code as it applies within the jurisdiction of the
39 county or city. The minimum performance standards of the codes and the
40 objectives enumerated in RCW 19.27.020 shall not be diminished by any
41 county amendments.
42

43 2. Amendments to chapter 30.52F SCC are necessary to consolidate
44 duplicative language in the general administrative provisions of chapters
45 30.52A and 30.52F SCC into chapter 30.50 SCC, which is being amended
46 to include the administrative provisions applicable to the building code and
47 other construction codes.
48

3. Amendments to SCC 30.52F.010 are necessary to delete 2009 and replace with 2012, to not adopt chapter 1 of the IRC as amended by the Washington State Building Code Council and included in chapter 19.27 RCW and add a reference to chapter 30.50 SCC.
4. Amendments to SCC 30.52F.020 are necessary to delete the 2009 reference, and add a reference to chapter 30.50 SCC.
5. Repealing SCC 30.52F.030 through SCC 30.52F.299 is necessary to reduce redundancy with chapter 30.50 SCC, which is being amended by adding the administrative provisions applicable to the residential code and other construction codes.
6. Amendments to SCC 30.52F.300 are necessary to modify IRC Table R301.2(1) to add the units of measurement, add a new note to footnote "d," and add a new note to footnote "k."

Section 2. The county council makes the following conclusions:

- A. The county council concludes that this ordinance adopting the 2012 Edition of the IRC adopted by the International Code Council as amended by the State of Washington on November 8, 2012, together with local amendments permitted under RCW 19.27.040, is in the best interest of Snohomish County.
- B. The county council concludes that the ordinance is consistent with the recent updates to the State Building Code Act adopted in chapter 19.27 RCW that became effective July 1, 2013.
- C. The county council concludes that the ordinance promotes the health, safety and welfare of the occupants or users of buildings and structures and the general public by providing building codes that require minimum performance standards and requirements for construction and construction materials, consistent with nationally accepted standards of engineering, fire and life safety. The council also concludes that the IRC and associated amendments allow the use of modern technical methods, devices and improvements and provide the standards and specifications for making buildings and facilities accessible to and usable by physically disabled persons.
- D. The county council concludes that adoption of the proposed amendments to the State Building Code will not result in less restrictive performance standards or objectives than those in the State Building Code.
- E. The county council concludes that this ordinance does not adopt development regulations under SCC 30.10.080. Therefore, planning commission review is not required pursuant to SCC 30.73.040(2)(c).
- F. The county council concludes that this ordinance does not adopt development regulations under SCC 30.10.080. Therefore, notice to Commerce of intent to adopt is not required pursuant to RCW 36.70A.106.

3 Environmental Policy Act is not required pursuant to WAC 197-11-800(20).

- a. Weathering may require a higher strength concrete or grade of masonry than necessary to satisfy the structural requirements of the residential code. The weathering column shall be filled in with the weathering index (i.e., "negligible," "moderate" or "severe") for concrete as determined from the Weathering Probability Map [Figure R.301.2(3)]. The grade of masonry units shall be determined from ASTM C 34, C 55, C 62, C 73, C 90, C 129, C 145, C 216 or C 652.
- b. The frost line depth may require deeper footings than indicated in Figure ((F403.4(1))) R403.1(1). The jurisdiction shall fill in the frost line depth column with the minimum depth of footing below finish grade.
- c. The jurisdiction shall fill in this part of the table to indicate the need for protection depending on whether there has been a history of local subterranean termite damage.

- d. The jurisdiction shall fill in this part of the table with the wind speed from the basic wind speed map [Figure R301.2(4)]. Wind exposure category shall be determined on a site-specific basis in accordance with Section R301.2.1.4.
- e. The outdoor design dry-bulb temperature shall be selected from the columns of 97 1/2-percent values for winter from Appendix D of the International Plumbing Code. Deviations from the Appendix D temperatures shall be permitted to reflect local climates or local weather experience as determined by the building official.
- f. The jurisdiction shall fill in this part of the table with the seismic design category determined from Section R301.2.2.1.
- g. The jurisdiction shall fill in this part of the table with (a) the date of the jurisdiction's entry into the National Flood Insurance Program (date of adoption of the first code or ordinance for management of flood hazard areas), (b) the date(s) of the Flood Insurance Study, and (c) the date(s) of the currently effective FIRM and FBFM, or other flood hazard map adopted by the county, as may be amended.
- h. In accordance with Sections R905.2.7.1, R905.4.3.1, R905.5.3.1, R905.6.3.1, R905.7.3.1 and R905.8.3.1, where there has been a history of local damage from the effects of ice damming, the jurisdiction shall fill in this part of the table with "YES". Otherwise, the jurisdiction shall fill in this part of the table with "NO".
- i. The jurisdiction shall fill in this part of the table with the 100-year return period air freezing index (BF-days) from Figure R403.3.(2) or from the 100-year (99%) value on the National Climatic Data Center data table "Air Freezing Index - USA Method (Base 32 o Fahrenheit)" at www.ncdc.noaa.gov/fpsf.html.
- j. The jurisdiction shall fill in this part of the table with the mean annual temperature from the National Climatic Data Center data table "Air Freezing Index-USA Method (Base ((32°)) 32° Fahrenheit)" at www.ncdc.noaa.gov/fpsf.html.
- k. In accordance with Section R301.2.1.5, where there is local historical data documenting structural damage to buildings due to topographic wind speed-up effects, the jurisdiction shall fill in this part of the table with "YES." Otherwise, the jurisdiction shall indicate "NO" in this part of the table.

Note to footnote d: Minimum 110 mph ultimate design wind speed to be used for buildings designed according to the International Building Code.

Note to footnote k: Topographical effects shall be included for buildings designed according to the International Building Code.


Section 90. Severability and Savings. If any section, sentence, clause or phrase of this ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause, or phrase of this ordinance. Provided, however, that if any section, sentence, clause, or phrase of this ordinance is held to be invalid by a court of competent jurisdiction, then the section, sentence, clause, or phrase in effect prior to the effective date of this ordinance shall be in full force and effect for that individual section, sentence, clause, or phrase as if this ordinance had never been adopted.
