ORDINANCE NO. 15-001

REPEALING AND REPLACING CHAPTER 2.52 SCC

BE IT ORDAINED:

Section 1. The Snohomish County Code Chapter 2.52, enacted by resolution on July 10, 1967 is repealed and replaced with:

**Chapter 2.52**  
**DEVELOPMENTAL DISABILITIES ADVISORY BOARD**

**2.52.010 Developmental Disabilities Advisory Board.**

A developmental disabilities advisory board is hereby created and established to advise the county developmental disabilities program in its provision of services.

**2.52.020 Services.**

The developmental disability program may:

- (1) Coordinate the local developmental disability services within the county with available state services and other key public and private services;
- (2) Address key community service and resource needs through grants, projects, training, technical assistance, and dissemination of information;
- (3) Serve as an information and referral agency for individuals with developmental disabilities, their families, and the community at large; and
- (4) Make comprehensive plans for development of local services.

**2.52.030 Membership.**

The developmental disabilities advisory board shall consist of a maximum of fifteen members, at least one from each council district. Board members shall be appointed by the county council. At least five members shall be persons with developmental disabilities or family members of persons with developmental disabilities. The remainder of board members shall be

1 persons who are knowledgeable of or interested in community support for individuals with  
2 developmental disabilities and their families.

5 **2.52.040 Term—Compensation.**

6  
7 Board members shall serve no more than three consecutive full terms of three years.  
8 Upon a year off the board, a person may be reappointed to the board. Board members may not  
9 advise the county concerning any transaction in which the board member has a financial interest.  
10 Board members shall not receive compensation for their service on the board. Members may  
11 receive reimbursement for expenses incurred while participating in official board  
12 business/training, upon pre-approval by the designated county program manager.

15 **2.52.050 Program Funds.**



17 The county developmental disability program is authorized to receive funds from  
18 governmental sources and public/private grants and to spend the funds subject to the provisions  
19 of chapter 36.40 RCW, other statutes relating to expenditures by counties, and the Snohomish  
20 County Code.

23 **2.52.060 Program Manager.**



25 A qualified program manager shall be hired by the director of human services to  
26 administer and coordinate the above-mentioned services provided by the county developmental  
27 disabilities program. The program manager may be employed on a full or part-time basis, and  
28 need not be a resident of the county.
