20 Section 1. The County Council makes the following findings of fact: an emergency
21 appropriation in the amount of \$744,900 is necessary in the Road Fund 102 for the 2015 budget
22 year to provide expenditure authority for acquisition of certain real property owned by Canyon
23 Creek Church of The Assemblies of God for the purpose of developing a transit facility near the
24 intersection of State Route 9 and Cathcart Way.

1 Section 3. The County Council further finds as a fact that there is a need for additional
2 expenditure authority to pay for the acquisition of certain real property owned by Canyon Creek
3 Church of The Assemblies of God for the purpose of developing a transit facility near the
4 intersection of State Route 9 and Cathcart Way. The need for this appropriation was not known,
5 and could not have been determined, prior to the adoption of the 2015 budget. The Council
6 therefore finds that the need for the appropriation authorized by this ordinance constitutes a
7 public emergency that could not reasonably have been foreseen at the time of budget approval
8 and appropriation for the year 2015 and hereby authorizes the appropriation.




