RELATED TO THE 2016 BUDGET; MAKING A SUPPLEMENTAL APPROPRIATION IN GENERAL FUND 002 TO PROVIDE EXPENDITURE AUTHORITY FOR GRANT FUNDS RECEIVED FROM THE STATE JUSTICE INSTITUTE

WHEREAS, the State Justice Institute awarded the Snohomish County District Court a \$50,000.00 technical assistance grant to hire the National Center for State Courts to conduct a court study to assess District Court operations and make recommendations for improved efficiencies.

Section 1. The Snohomish County Council makes the following findings of fact: there are unexpected grant funds in the amount of \$50,000 from the State Justice Institute and that a supplemental appropriation in General Fund 002, for the 2016 budget year, in the amount of \$50,000.00, is necessary to provide expenditure authority related to a court operation study.
