8 RELATING TO LIQUOR ON CERTAIN COUNTY PROPERTIES;
9 AMENDING SCC 10.06.030

11 NOW, THEREFORE, BE IT ORDAINED:

12
13 Section 1. Snohomish County Code Section 10.06.030, last amended by
14 Ordinance 06-078 on October 11, 2016, is amended to read:

15
16 **10.06.030 Evergreen fairground and licensees of Snohomish county airport
17 and Snohomish county department of parks and recreation.**

18
19 The opening or consumption of alcoholic beverages shall be permitted on the
20 premises of the Evergreen fairground, as described in SCC 2.32.020; the
21 Snohomish county airport, as described in SCC 15.08.052 and ~~((the outdoor
22 patio of the Grand Terrace Room and indoor facilities at Willis Tucker Community
23 Park located at 6705 Puget Park Drive, Snohomish, WA 98296))~~other property
24 under the custodianship of the department of parks and recreation designated by
25 the director of parks and recreation pursuant to the terms of either a special
26 occasion license, pursuant to RCW 66.24.380 and Chapter 314-05 WAC, or a
27 banquet permit, pursuant to RCW 66.20.010 and Chapter 314-18 WAC,
28 hereinafter collectively referred to as liquor license, issued to the person
29 occupying such premises by the Washington state liquor control board;
30 PROVIDED, That such person shall have secured a license or permit to use such
31 premises, hereinafter referred to as a facility license, from Snohomish county,
32 and PROVIDED, FURTHER, That:

33
34 (1) No such facility license shall be issued by Snohomish county except upon
35 written application stating that the licensee intends to seek a Washington state
36 liquor license and the terms of such license;

37
38 (2) No liquor shall be served at a licensed event until the county receives written
39 confirmation of the licensee's successful application for a liquor license from the
40 Washington state liquor control board;

41
42 (3) The licensee shall indemnify and hold Snohomish county harmless from any
43 liability arising out of any activity conducted permitted by such licensee on county
44 property;

45
46 (4) The licensee shall provide commercial general liability insurance in an
47 amount not less than \$1,000,000 combined single limit bodily injury and property

1 damage. Coverage shall include host liquor liability if alcohol is provided and/or
2 liquor liability if liquor is sold. Liquor liability and/or host liquor liability must be
3 noted on the evidence of insurance. Snohomish county, its officers, and
4 employees shall be named as additional insured, with an additional insured
5 endorsement. The policy shall not be reduced or cancelled without 45 days'
6 written notice to the county. The licensee shall provide to the county a certificate
7 of insurance with endorsements prior to the event and, upon written request of
8 the county, a duplicate of the policy as evidence of the insurance provided;
9

10 (5) If required by the director of the airport or the director of the department of
11 parks and recreation, the licensee shall provide crowd control by the sheriff's
12 reserve, other police reserve, or such other security personnel as approved by
13 the sheriff of Snohomish county. At the discretion of the county executive, the
14 director of the airport, the director of the department of parks and recreation, or
15 the sheriff, any facility license issued by the county for use of any premises of the
16 Evergreen Fairground, the Snohomish county airport, or ~~((the specified premises
17 at Willis Tucker Community Park))~~ other property under the custodianship of the
18 department of parks and recreation designated by the director of parks and
19 recreation may be revoked at any time if such licensee shall fail to adequately
20 police and control the sale, service, or consumption of liquor pursuant to a valid
21 liquor license issued to it from the Washington state liquor control board or if
22 such licensee violates any terms of its facility license.
