8 AN ORDINANCE APPROVING THE 2019 ANNUAL CONSTRUCTION PROGRAM FOR  
9 COUNTY TRANSPORTATION IMPROVEMENTS

11 WHEREAS, RCW 36.81.130 calls for the county road engineer to file with the county  
12 legislative authority, for consideration and adoption, a plan for the laying out, construction  
13 and maintenance of all county roads for the ensuing fiscal year; and  
14

15 WHEREAS, the Snohomish County Engineer has submitted the 2019 Annual  
16 Construction Program for Transportation to the County Council for consideration in  
17 accordance with RCW 36.81.130; and  
18

19 WHEREAS, the 2019 Annual Construction Program for Transportation is attached  
20 hereto as Exhibit A; and

22 WHEREAS, this annual construction program conforms as nearly as practicable to  
23 the County's long-range road program and comprehensive plan as contained in the 2019-  
24 2024 Six-Year Transportation Improvement Program, adopted November 19, 2018, by  
25 Motion No. 18-335, and in the Transportation Element for the Snohomish County  
26 Comprehensive Plan, adopted on June 10, 2015, in Amended Ordinance No. 14-137; and


28 WHEREAS, the 2019 Annual Construction Program for Transportation meets all


