BE IT ORDAINED:

Section 1. The County Council makes the following findings of fact: a supplemental appropriation in General Fund 002, for the budget year 2018, in the amount of \$572,000, is necessary to provide expenditure authority for funds received from various municipalities associated with conducting the April and February 2018 Snohomish County special elections.

Section 2. The unit and allocation detail for the supplemental appropriation described in Section 1 are as follows:
