10 APPROVAL OF AN INTERLOCAL AGREEMENT BETWEEN SNOHOMISH COUNTY
11 AND THE CITY OF BOTHELL CONCERNING THE DESIGN OF ROAD IMPROVEMENTS
12 TO 228TH ST SE FROM 35TH AVE SE TO 39TH AVE SE

15 WHEREAS, the County and City desire to jointly design improvements to 228th St SE
16 from approximately four hundred feet west of 35th Ave SE to approximately three hundred feet
17 east of 39th Ave SE and approximately one hundred and fifty feet south on 35th Ave SE and north
18 on 39th Ave SE, hereinafter the "Project"; and

20 WHEREAS, the Project will consist of widening 228th St from three to four lanes and
21 include bike lanes, intersection improvements, curbs, gutters, sidewalks, lighting, signals and
22 signal interconnect; and

24 WHEREAS, the County and the City agree that it will be more efficient and mutually
25 beneficial to work cooperatively together and to enter into an Interlocal Agreement whereby the
26 City will be the lead for the design of the Project, which is anticipated to start in 2019.


28 NOW, THEREFORE, BE IT ORDAINED:

30 Section 1. The County Council hereby adopts the foregoing recitals as findings of fact
31 and conclusions as if set forth in full herein.

33 Section 2. The Snohomish County Council approves and authorizes the Snohomish
34 County Executive, or designee, to execute the Interlocal Agreement between Snohomish County
35 and the City of Bothell concerning the design of road improvements to 228th St SE from 35th Ave
36 SE to 39th Ave SE.
