9 AUTHORIZING AN INCREASE IN GENERAL TAX REVENUES
10 FOR PROPERTY TAXES COLLECTED IN 2021



12 WHEREAS, the County Council held a public hearing on November 10, 2020,
13 following public notice as required by law to consider the County's annual budget,
14 including revenue sources for calendar year 2021, pursuant to RCW 84.55.120; and
15

16 WHEREAS, the County Council, after hearing and duly considering all relevant
17 evidence and testimony presented, including evidence and testimony presented upon
18 consideration of proposed Ordinance No. 20-060, has determined that an increase in
19 general tax revenue from the previous year, in addition to the increases resulting from
20 the addition of new construction, improvements to property, newly constructed wind
21 turbine facilities, and any increase in the value of state-assessed property under RCW
22 84.55.010, and from the refund provisions of Chapters 84.68 and 84.69 RCW, is
23 necessary in order to discharge the expected expenses and obligations of the County
24 and in its best interests.

26 NOW, THEREFORE, BE IT ORDAINED, pursuant to RCW 84.55.120, that an
27 increase in property tax revenues for taxes collected in 2021, in addition to the
28 increases resulting from the addition of new construction, improvements to property,
29 newly constructed wind turbine facilities, and any increase in the value of state-
30 assessed property under RCW 84.55.010 and from the refund provisions of Chapters
31 84.68 and 84.69 RCW, is hereby authorized in the amount of \$0 for the 2021 general
32 levy, which is a percentage increase of 0 (zero) percent from the previous year.
