22	84.69 RCW, is necessary in order to discharge the expected expenses and obligations			
23	of the County and in its best interests.

26	increase in property tax revenues for taxes collected in 2021, in addition to the			
27	increases resulting from the addition of new construction, improvements to property,

29	assessed property under RCW 84.55.010 and from the refund provisions of Chapters			
30	84.68 and 84.69 RCW, is hereby authorized in the amount of \$40,594 for the 2021			
31	conservation futures levy, which is a percentage increase of one (1) percent from the			
32	previous year.
