On 21 February 29, 2020, Washington State Governor Jay Inslee proclaimed a public health emergency 22 for COVID-19. On March 4, 2020, the Snohomish County Health Officer proclaimed a 23 countywide public health emergency for COVID-19. On March 4, 2020, Executive Dave Somers 24 issued a "Local Proclamation of Emergency Snohomish County" for COVID-19 (the 25 "Emergency"). On March 13, 2020, the President of the United States of America declared 26 COVID-19 a National Emergency; 27 28 WHEREAS, since March 2020, the County has been responding to the pandemic, 29 providing funds for public health and medical response, economic stabilization, human services, and essential government services; and 30 31 32 WHEREAS, the need for these services during the COVID-19 pandemic is ongoing. 33 34 35 BE IT ORDAINED: 36 37 Section 1. The County Council makes the following findings of fact: An emergency 38 appropriation in the amount of \$3,512,342 is necessary in Grant Control Fund 130 for budget year 39 2021 to provide expenditure authority for unanticipated costs associated with the continuing 40 response to the COVID-19 pandemic. 41 42 Section 2.
