ORDINANCE NO. 23-084

RELATING TO THE 2023 BUDGET; MAKING A SUPPLEMENTAL
APPROPRIATION IN GENERAL FUND 002 TO PROVIDE
EXPENDITURE AUTHORITY FOR DISTRICT COURT MENTAL HEALTH COURT

WHEREAS, the Washington State Administrative Office of the Courts is providing grant funding to District Court to support District Court's Mental Health Court. Specifically, the funding continues the Mental Health Program Coordinator increase from 0.5 to 1.0 FTE, the Legal Process Assistant II increase from 0.5 to 1.0 FTE, will retain the 1.0 FTE Therapeutic Court Case Manager, and will provide additional funding for equipment, training, supplies, and recovery support.

NOW, BE IT ORDAINED:

Section 1. The County Council makes the following finding of fact: a supplemental appropriation in the amount of \$162,648.67, is necessary in General Fund 002, for budget year 2023, to provide expenditure authority to fund staffing and other services for District Court's Mental Health Court. The increased staffing and services are funded by revenue received from the Washington State Administrative Office of the Courts.
