AN ORDINANCE CREATING A LEASH LAW ZONE  
PURSUANT TO SNOHOMISH COUNTY CODE 9.14  
AND ADDING AN ADDITIONAL SECTION TO  
SNOHOMISH COUNTY CODE 9.14.111

BE IT ORDAINED AS FOLLOWS:

Section 1.

A new subsection is added to Snohomish County Code 9.14.111 as follows:

Section 9.14.111(10) A leash law zone known as Gravenstein Road, 172nd Pl. S.W. and Clover Road, with the following boundaries is hereby established:

Beginning at the northeast corner of Lot 3 of the plat of Alderwood Manor No. 5, Block 3, as recorded under volume 9, pages 79 through 83 of the Snohomish County auditor's file and the east line of section 12, township 27N, range 4 E.W.M., said point to be the true point of beginning, thence south along the east line of said lot 3 to the southeast corner of lot 8 of said plat; thence west along south line of south lot 8 to the southwest corner of lot 9 of said plat; thence north along west line to its intersection with the south line of lot 10; thence west along said south line to the southwest corner of lot 10; thence north along west line of lot 10 to the northwest corner of lot 12; thence east approximately 30 feet more or less along the south line of said lot 12; thence north to its intersection with the south line of lot 5, of the plat of Woodland View as recorded under volume 34, page 21 of the Snohomish County auditor's file; thence northwesterly along said south line to a point that is 200 feet more or less southeasterly of the easterly right of way of Gravenstein Road, thence southwesterly and parallel to Gravenstein Road for approximately 200 feet; thence northwesterly and parallel to the south line of the plat of Woodland View and extended across Gravenstein Road to the westerly right of way of said road; thence northeasterly along said westerly right of way to the south line of the Plat of Holly "B" as recorded under volume 28, page 94 of the Snohomish County auditor's file; thence west along said south line to the west line of said plat; thence north along said west line to the north line of said plat; thence east along said north line to the southeast corner of lot 24 of the plat of Forrest View as recorded under volume 39 pages 175 and 176 of the Snohomish County auditor's file; thence north, northeasterly,

southeasterly and south along the westerly, northerly and easterly boundaries of lots 25, 26, 27, 29 and 28 to the southeast corner of lot 28 of said plat, thence east approximately 100 feet more or less, thence south 255 feet to the north line of lot 2, of the Plat of Alderwood Manor No. 5, Block 3, thence east 195 feet more or less along said north line, thence south 260 feet more or less to the north line of lot 3 of said plat, thence east along said north line to the true point of beginning.
