BE IT RESOLVED:

Section 1. A new chapter and sections are added to the  
Snohomish County code as follows:

CHAPTER 2.100

FINANCIAL MANAGEMENT

2.100.010 Office of Financial Management

2.100.020 Financial Director

2.100.030 Appointment

2.100.010 Office of Financial Management. The Office  
of Financial Management shall be responsible for the  
operation and management of such financial activities of the  
county as are delegated to it by Ordinance. The chief of the  
office shall be the Financial Director.

2.100.020 Financial Director. The Financial Director  
shall be responsible for the preparation of a plan or plans

for the reorganization of county financial operations with a single efficient system, insofar as practicable and legally possible, the preparation of financial reports and financial information as requested, the recommendation of changes to the Executive for the improvement of financial procedures, for the performance of such financial duties .

as are delegated by the Executive, and the performance of such other duties as are delegated to him by Ordinance. The Financial Director shall be responsible to the Executive.

2.100.030 Appointment. The Financial Director shall be appointed by the Executive, subject to confirmation by the Council. He shall serve at the pleasure of the Executive.

Section 2. A new chapter and section are added to the Snohomish County Code as follows:

#### CHAPTER 2.200

##### MANAGEMENT AND PROGRAM DEVELOPMENT

2.200.010 Office of Management and Program Development

2.200.010 Office of Management and Program Development.

The Office of Management and Program Development shall be

responsible for such financial planning and program development as are delegated to it by Ordinance. '

Section 3. A new chapter and section are added to the Snohomish County Code as follows:

CHAPTER 2.500

SUPPORT SERVICES

2.500.010 Office of Support Services.

~~2.500.010 Office of Support Services.~~ The Office of Support Services shall be responsible for such support service functions including property management, print shop, building and maintenance and such other duties as are delegated by Ordinance.
