Be It Ordained:

Section 1. Snohomish County Code Sections 2.32.080, 2.32.093 and 2.32.094, as adopted by resolutions dated July 25, 1977, October 26, 1971, and October 26, 1976, are amended and a new section added as follows:

2.32.080 Membership of Fair Board. The Fair Board shall be composed of ~~((nine-members-who-shall-serve-without-compensation))~~ eleven members, ~~((except-as-otherwise-provided-pursuant-to-Section-2.32.077(1)-Three))~~ Two positions for membership shall be appointed from each ~~((commissioner))~~ council district. One member shall serve at-large ~~((Nominees-for-membership))~~ and members shall reside in the ~~((commissioner))~~ council district from which ~~the-position-is-assigned~~ they are appointed. One member shall serve at-large and may reside anywhere within the county. Appointment shall be by the ~~((majority-of-the-board-of-commissioners))~~ county council from ~~((lists-of-nominees-submitted-by-the-commissioners-of-the-commission-district-to-which-the-position-was-assigned))~~ executive recommendations made pursuant to this chapter and pursuant to provisions enacted for executive recommendations on boards and commissions in general. Recommendations shall balance interests in both fair-related and year-round activities at the fair grounds. The following interests should be represented by board members: youth groups, senior citizens, homemakers, arts and crafts, recreation, business and economy, racing and a broad range of agricultural interests.

2.32.081 Compensation. The fair board members shall be reimbursed for mileage to and from meetings, and for other expenses as approved by the executive, as limited by budgetary constraints and shall be reimbursed as otherwise provided in Section 2.32.077(1).

2.32.093 Vacancies. A position shall become vacant within the period of term upon the death, resignation, removal or change of residence outside the ~~((commissioner))~~ council district of appointment of a member of the fair board. Any vacancy shall be filled by appointment in the same manner as the appointment of the preceding member, and any appointee to fill a vacancy, other than for expiration of term, shall serve only for the balance of the full term of his predecessor.

2.32.094 Removal. Any member of the fair board may be removed by the ~~((chairman-of-the-board-of-commissioners-with-approval-of-the-board-of-commissioners))~~ council for neglect of duty or malfeasance in office, and pursuant to general removal provisions enacted for county boards and commissions.

Section 2. Snohomish County Code sections 2.32.091, 2.32.092 and 2.32.101 as adopted by resolution dated October 26, 1971, are repealed.
