ORDINANCE NO. 86-008

ESTABLISHING DOG LEASH LAW ZONE,  
AMENDING SNOHOMISH COUNTY CODE CHAPTER 9

BE IT ORDAINED:

~~Section 1:~~ Snohomish County Code, Chapter 9, adopted July 10, 1978 and last amended by Ordinance No. 85-082, adopted August 21, 1985, is amended to read as follows:

~~9.14.111 Dog-leash-law-zones.~~ The following are established as dog leash law zones:

- (1) In the unincorporated areas of Snohomish County.

Boundaries:

(A) On the north, the centerline of 172nd Street N.E. between Interstate 5 and Highway 9;

(B) On the east, the centerline of Highway 9 between 172nd Street N.E. and the King County boundary;

(C) On the south, the King County boundary between Puget Sound and Highway 9;

(D) On the west, the centerline of Interstate 5 between 172nd Street and Hewitt Avenue; Puget Sound between Hewitt Avenue and the King County boundary.

- (2) Marysville West and Tierra Bonita.

Boundaries:

(A) On the north, the centerline of 72nd Drive N.E. between 19th Ave. N.E. and 23rd Drive N.E.;

(B) On the east, the centerline of 23rd Drive N.E. between 72nd Street N.E. and Tulalip Highway (Marine Drive);

(C) On the south, the centerline of Tulalip Drive (Marine Drive) between 19th Avenue N.E. and 23rd Drive N.E.;

(D) On the west, the centerline of 9th Avenue N.E. between Tulalip Drive (Marine Drive) and 72nd Street N.E. (Ord. 82-114 SS7, adopted December 16, 1982).

(3) Bunk Foss and Highway 9.

Boundaries:

(A) On the north, the centerline of 32nd Street SE between Highway 9 and 103rd Avenue SE;

(B) On the east, the centerline of 103rd Avenue SE between 32nd Street SE and 44th Street SE;

(C) On the south, the centerline of 44th Street SE between Highway 9 and 103rd Avenue SE;

(D) On the west, the centerline of Highway 9 between 32nd Street SE and 44th Street SE.

(4) Cedar Village II and III

Boundaries:

(A) On the north, the centerline of 198th Place N.E. (Cemetery Road) between the centerline of 47th Avenue N.E. and 51st Drive N.E.

(B) On the east, the Arlington City Limits just west of 51st Drive N.E. from 198th Place N.E. to south Arlington City Limits

(C) On the south, the Arlington City Limits from 51st Drive N.E. to the centerline of 47th Avenue N.E.

(D) On the west, the centerline of 47th Avenue N.E. between 198th Place N.E. and the Arlington City Limit.

(5) Mountain View Estates

Boundaries:

(A) On the north, Community Tract C (1, 7, 8, 9) along 66th Street NE and Community Tract A (10 through 23) access road 65th Place NE, 119th Drive NE and 66th St. NE.

(B) On the east, Community Tract B (70) and Community Tract C (1, 2, 3, 4, 5) along Hartford-Gretchen Road.

(C) On the south, Community Tract A (43 through 52) and Community Tract B (68, 69, 70) access roads 64th Place NE, 119th Drive NE and 120th Drive NE.

~~(D) On the west, Community Tract A (23, 24, 25, 43) access road 117th Avenue.~~
