RELATING TO COUNTY ROADS

## BE IT ORDAINED:

Section 1. A new section is added to the Snohomish County Code as follows:

## 26B.52.030 Master Road Improvement Program.

- (1) Where a road system or any other county road or roads, or portions thereof, are subject to present or future road uses, including those of developers of abutters and nearby properties, resulting in serious problems with respect to the safety of persons and property, real and personal, and the public welfare, the Director may propose a Master Road Improvement Program designed to resolve the problems and bring about adequate levels of service. Such a program, in full or in part, may be considered in determining whether or how the requirements of this chapter may be complied with on the road system or roads involved.
- (2) Master Road Improvement Programs proposed by the Director shall be subject to review and approval by the Council.
  - (3) A Master Road Improvement Program shall include:
  - (a) A description of the road or roads, or portions thereof, involved;
  - (b) Analysis of a traffic study and analysis of existing and future conditions anticipated on the road or roads involved;
    - (c) Proposed improvements;

- (d) A financial system, including a plan for calculating the proportionate shares of road costs to be contributed by owners, developers, the county, and other jurisdictions.
- improvement plan adequately addresses the issues of public safety and amelioraton of present and future traffic hazards, as required by sections 26B.52.010, 26B.52.020, Ch. 26B.53, Ch. 26B.54, developer obligations contained in sections 26B.55.020 26B.55.050, 26B.55.060 or 26B.55.080, it may adopt all or parts of such plan in lieu of satisfaction of the requirements contained in said sections. Once said master road improvement plan has been adopted by the Council, the provisions of the above-referenced sections notwithstanding, the county shall issue permits and approvals for development provided the applicant complies with the provisions of other applicable local ordinances and agrees to comply with the developer obligations in the master road improvement plat including payment of the proportionate share fees provided therein if any.
