EMERGENCY ORDINANCE NO. 86-084

AMENDING THE MANAGEMENT AND EXEMPT EMPLOYEES COMPENSATION PLAN;  
 WAGE AND SALARY SCHEDULE

Be it ordained:

Section 1. The Council finds as a fact that an emergency exists and that this ordinance is necessary for the support of county government and its existing institutions and immediate approval of this ordinance is necessary to implement needed changes in the management and exempt employees compensation plan to become effective in July, 1986.

Section 2. That section 3.69.030 of the Snohomish County Code adopted by Ordinance on November 20, 1985, is hereby amended as follows:
