ORDINANCE 88- 029

DELAYING THE EFFECTIVE IMPLEMENTATION OF THE COUNTYWIDE DISTRICT COURT
FROM MAY 1, 1988 TO AUGUST 15, 1988, AND AMENDING
SNOHOMISH COUNTY CODE CHAPTER 2.12

BE IT ORDAINED:

SECTION 1. Snohomish County Code, Section 2.12.011, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.011 Reduction of Everett District judge positions; repeal.

(1) The number of judges to be elected in the Everett District shall be reduced to two, effective January 10, 1983.

(2) This section is hereby repealed on ((May-17--1988)) August 15, 1988.

SECTION 2. Snohomish County Code, Section 2.12.012, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.012 District judge position added, South District; repeal.

(1) There is hereby added one full time justice position to the South District in addition to the number of positions authorized for said district prior to the passage of this 1982 ordinance. The term of office of this additional justice position shall commence January 10, 1983.

(2) This section is hereby repealed on ((May-17--1988)) August 15, 1988.

SECTION 3. Snohomish County Code, Section 2.12.013, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.013 Election of additional district judge; repeal.

(1) The county auditor shall accept declarations of candidacy for the office created by Section 2.12.012 during the filing period provided by law prior to the primary election, to be held on September 14, 1982, and the general election to be held on the first Tuesday of November, 1982. The county auditor shall not accept declarations for candidacy nor provide ballot positions for more than two justice positions for the Everett District in the primary election, to be held on September 14, 1982, and the general election to be held on the first Tuesday of November, 1982.

(2) The office created by Section 2.12.012 shall become effective January 10, 1983. Such office shall be filled by the person elected and qualified at the general election immediately preceding such effective date.

(3) This section is hereby repealed on ((May-17--1988)) August 15, 1988.

SECTION 4. Snohomish County Code, Section 2.12.015, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.015 Dissolution; of districts; termination of district justice positions.

(1) The Cascade, Evergreen, Everett and South Justice Court Districts shall be dissolved on (~~May-17-1988~~) August 15, 1988.

(2) All district court justice positions for Cascade, Evergreen, Everett and South Justice Court Districts are terminated on (~~May-17-1988~~) August 15, 1988.

SECTION 5. Snohomish County Code, Section 2.12.016, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.016 Creation of district. On and after (~~May-17-1988~~) August 15, 1988, there shall be established a single, county-wide justice court district to be known as the Snohomish County Justice Court District.

SECTION 6. Snohomish County Code, Section 2.12.017, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.017 Election of district judges.

(1) The county auditor shall accept declarations of candidacy for the offices created by Section 2.12.071 during the filing period provided by law prior to the general election to be held on the first Tuesday of November, 1986.

(2) The offices created by Section 2.12.071 shall become effective (~~May-17-1988~~) August 15, 1988. Such offices shall be filled by persons elected and qualified at the general election immediately preceding such effective date.

(3) District court judges shall be elected by judicial district if, at the time of the 1986 election, such electoral districts are authorized by state law. If such electoral districts are not authorized by state law, the district court judges shall be elected county-wide.

SECTION 7. Snohomish County Code, Section 2.12.020, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.020 Cascade District boundaries, repeal.

(1) The justice court district in north Snohomish County, known as "Cascade District," shall be revised to include all the land lying within the following voting precincts. A complete legal description of the precinct boundaries is on file with the county auditor.

SECTION 11. Snohomish County Code, Section 2.12.070, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.070 Number of judges per district; repeal.

(1) The number of judges to be elected in each district shall be as follows:

Cascade	one full-time judge
Evergreen	one full-time judge
Everett	two full-time judges
South	three full-time judges

(2) This section is hereby repealed on ((May-17--1988)) August 15, 1988.

SECTION 12. Snohomish County Code, Section 2.12.071, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.071 Number of judges. There shall be seven judges elected in the county justice court district. The terms of office of said judges shall commence ((May-17-1988)) August 15, 1988.

SECTION 13. Snohomish County Code, Section 2.12.080, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.080 Location of central offices, courtrooms, and records; repeal.

(1) The central offices, courtrooms, and records of each district shall be located as follows:

Cascade District	County court facility, Arlington
Evergreen District	County court facility, Monroe
Everett District	County Courthouse, Everett
South District	South Snohomish County Judicial Building, Lynnwood

(2) This section is hereby repealed on ((May-17--1988)) August 15, 1988.

SECTION 14. Snohomish County Code, Section 2.12.110, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.110 Departments; repeal.

(1) The Everett District shall be divided into departments No. 1 and No. 2. The South District shall be divided into departments No. 1, No. 2, and No. 3.


(2) This section is hereby repealed on ((May-17--1988)) August 15, 1988.

SECTION 15. Snohomish County Code, Section 2.12.140, last amended by Ordinance 86-050, on June 11, 1986 is amended as follows:

2.12.140 Effective dates of amendments. The effective date of Sections 2, 3, and 4 of Ordinance 82-042 dated June 29, 1982 and codified as Sections 2.12.011 through 2.12.013, 2.12.015 through 2.12.018, 2.12.020 through 2.12.050, 2.12.070, 2.12.080 and 2.12.110 shall be January 10, 1983. The effective date of Section 5 of this ordinance and codified as Sections 2.12.021, 2.12.071, 2.12.081 and 2.12.211 shall be ((May-17--1988)) August 15, 1988.
