ORDINANCE NO. 88-073

AMMENDING THE SNOHOMISH COUNTY CODE TO ADD A NEW CHAPTER 1.18
ADOPTING THE OFFICIAL COUNTY FLAG

WHEREAS, the Washington State Centennial Commission has requested that each county submit a flag representing their county for the Centennial Celebration; and

WHEREAS, the flag will provide an opportunity to raise the visibility of Snohomish County in the public's eye and unify the government entities around the state; and

WHEREAS, the county flag will fly proudly in the State Capitol Rotunda next year along with flags from all other counties in Washington, sponsored by the Washington State Association of Counties; and

WHEREAS, The Herald newspaper, in conjunction with the Snohomish County Centennial Committee and Snohomish County government, sponsored an official county-wide competition for the design of the new Snohomish County flag; and

WHEREAS, the contest judges chose the design by Susan DiPietro of Mukilteo for the Snohomish County flag; and

WHEREAS, on Sunday, September 4, 1988, the finished flag will be unfurled at the Evergreen State Fair in Monroe and representatives of the county's municipalities will each be presented with a new flag;

NOW, THEREFORE, BE IT ORDAINED:

A new Chapter 1.18 is added to the Snohomish County Code as follows:

Chapter 1.18

OFFICIAL COUNTY FLAG

Sections:

1.18.010 County Flag adopted.

1.18.010 County Flag adopted. The flag, designed by Susan DiPietro of Mukilteo, is hereby adopted as the official county flag of Snohomish, Washington. The flag shall be of white background and

shall depict three trees as shown below. The left tree shall be in the color red, the center tree blue, and the right tree green. The words "Snohomish County" written below the tree shall be in the color green. The dimensions of the flag shall be 3' by 5' and the edge of the flag shall not be fringed.
