

COUNTY COUNCIL Snohomish County, Washington Amended ORDINANCE NO. 90- 059



Relating to solid waste; changing the composition of the solid waste advisory committee:

Amending Snohomish County Code Chapter 7.34

WHEREAS, the County Council has adopted the revised Snohomish County Comprehensive Solid Waste Management Plan; and

WHEREAS, a majority of the incorporated cities and towns within the county have signed an interlocal agreement assigning to Snohomish County responsibility for disposal of their waste stream for a period of twenty years; and

WHEREAS, some of those municipalities have expressed a desire
to have a voice in solid waste issues and planning, with the ability to
make recommendations to the Solid Waste Management Division and
the County Council regarding such matters; and

WHEREAS, Snohomish County desires to keep the municipalities informed and involved in solid waste management issues; and

WHEREAS, the Snohomish County Solid Waste Advisory Committee currently consists of nine voting members, four of whom represent cities and towns, with the remaining five being selected from the Council Districts; and

WHEREAS, State Law requires a minimum of nine members on a SWAC, but does not list a maximum;

NOW, THEREFORE, BE IT ORDAINED:

<u>Section 1.</u> Snohomish County Code Section 7.34.020 adopted by Ordinance 85-042 on May 15, 1985, is amended as follows:

- <u>7.34.020 Composition of committee.</u> Membership of the solid waste advisory committee shall be as follows:
- (1) Regular members. The solid waste advisory committee shall consist of:
 - (a) Two members who are elected officials selected from Snohomish county municipalities whose population is 10,000 or greater, based on the latest census. One member from each city and town in Snohomish county which is a signatory to the effective county comprehensive solid waste management plan, to be nominated by the legislative authority for that municipality and appointed by the county council.
 - (b) Two members who are elected officials selected from Snohomish county municipalities whose population is less than 10,000, based on the latest census.

(e) (b) Five members, selected, one each representing the unincorporated area of each one of the five county council districts. The five members will shall be recommended by the executive and appointed by the county council. The executive will provide shall recommend candidates representing a wide spectrum of citizens, public interest groups, and businesses, and the waste management industry and who are residents of, or who are representatives of Candidates shall be residents of Snohomish county or represent firms licensed to do business in Snohomish county.

(d) (c) Six Four non-voting members will shall be selected, one two each; to represent general industry, commercial solid waste collection firms, one voting and one non-voting; and two to represent commercial recycling firms, citizens, public interest groups and other businesses; one voting and one non-voting. These members shall be recommended by the executive

and appointed by the county council.

(d) One ex officio, non-voting representative from the Snohomish county solid waste management division.

(e) One ex officio, non-voting representative from the

department of ecology.

(f) One ex officio, non-voting representative from the Snohomish Health District.

(2) Auxiliary members. The regular membership of the solid waste advisory committee may appoint auxiliary members for a specific time period to serve on the committee in a non-voting capacity, for the purpose of providing specific information, technical advice, information of a general nature which is pertinent to the committee's activities or any other form of assistance which will aid the committee in carrying out its purposes.

(3) Term of office. Terms of office for regular members shall be for a two-year period from the date of appointment, whether the member is appointed at the commencement of an initial term or at a

point thereafter.

<u>Section 2.</u> Snohomish County Code Section 7.34.050 adopted by Ordinance 85-042, Section 2 (part), on May 15, 1985, is amended to read as follows:

7.34.050 Meetings. The solid waste advisory committee shall meet as required to carry out the purposes of the committee. Meetings may be held at various locations within the county with written notification to the membership and chairman designating the time and place of such meetings. Meetings shall be held not less than quarterly. A quorum shall consist of five voting members in attendance a simple majority of the members on the committee. A majority of voting members will pass a motion.

<u>Section 3.</u> The Solid Waste Management Division is directed to inform the municipalities of this ordinance change, and to solicit their appointments of representatives to the newly constituted SWAC.

Section 4. The County Executive is directed to forward to the Council recommendations for replacements for any of the five Council district seats on the SWAC presently vacant, as well as recommendations for the members to represent the waste handling and recycling industries.
