AMENDING CHAPTER 4.32 OF THE SNOHOMISH COUNTY CODE RELATING TO FEES  
FOR RECORDING LAND SURVEYS

BE IT ORDAINED:

Section 1. The title of Snohomish County Code Chapter 4.32, adopted by Resolution on June 4, 1973, is amended to read:

FEES FOR RECORDING AND COPYING RECORDS OF LAND SURVEYS AND  
MONUMENTS, AND COPYING RECORDS OF PLATS, SHORT PLATS,  
CONDOMINIUMS AND BINDING SITE PLANS

Section 2. The headings of Snohomish County Code Chapter 4.32, adopted by Resolution on June 4, 1973, are amended to read:
