ORDINANCE NO. 92-090

RELATING TO THE TRANSPORTATION DEMAND MANAGEMENT PROVISIONS OF TITLE 26B SCC REMOVING THE AUTOMATIC REPEAL DATE OF AUGUST 31, 1992

WHEREAS, the automatic repeal date was set as February 9, 1992 by Amended Ordinance No. 91-025 and extended to August 31, 1992 by Ordinance 92-005, and

WHEREAS, the intent of the repeal date for the TDM provisions of Title 26B was the expectation that a separate ordinance would be put into effect by August 31, 1992 for the purpose of fully addressing all aspects of TDM as applied to both new development and existing employers required to reduce commute trips, and

WHEREAS, there has been no new information, process or guidelines put into effect to further address the programmatic or capital expenditure based TDM measures, and

WHEREAS, the eventual development of the necessary information, process, and guidelines to apply to TDM measures for new development should continue to be an element of the development's transportation mitigation requirements thus logically remaining codified in Title 26B,

NOW, THEREFORE, BE IT ORDAINED:

<u>Section 1.</u> Section 3 of Amended Ordinance No. 91-025, adopted February 20, 1991, (uncodified) as amended by Ordinance 92-005, adopted January 13, 1992, (uncodified) is hereby amended as follows:

Section 1 adding new section SCC 26B.55.140 and 2 amending SCC 26B.55.020 to address credit for SCC 26B.55.140 TDM requirements of Amended Ordinance No. 91-025, adopted February 20, 1991 are repealed on August 31, $((\frac{1992}{1993}))$ 1993.

<u>Section 2.</u> The Department of Public Works is further directed to expand the coverage of the TDM measures required by SCC 26B.55.140 to include programmatic measures and to eliminate the credit against capacity obligations allowed by SCC 26B.55.020.
