ORDINANCE NO. 93-007



AMENDING SNOHOMISH COUNTY CODE TITLE 4, CHAPTER 4.53, RELATING TO FEES CHARGED FOR PARTICIPATION IN THE COUNTY'S WORK RELEASE PROGRAM AND ADDING FEES FOR THE HOME DETENTION PROGRAM AND COMMUNITY SERVICE PROGRAMS.

WHEREAS the fee charged to Work Release participants has not increased since 1982; and

WHEREAS the Corrections Department has implemented the Home Detention and Community Service Programs and wishes to require participants in those programs to pay a fair share of the costs of those programs;

NOW, THEREFORE, BE IT ORDAINED:

Section 1. SCC 4.53.010, adopted by Ordinance 82-081 SS2 (part), on August 24, 1982, is amended to read as follows:

4.53.010 Purpose. Pursuant to RCW 70.48.210(3)(d) and (4), RCW 9.94.A .135 and .180 and RCW 9.94.030.34 and .36, as now enacted or hereinafter amended, Snohomish County makes every effort to require all participants in the work release, home detention and community service programs to pay a fair share of the costs of ~~that~~ those programs. (Ord. 82-081 SS2 (part), adopted August 24, 1982.)

Section 2. SCC 4.53.020, adopted by Ordinance 82-081 SS2 (part), on August 24, 1982, is amended to read as follows:

4.53.020 Fee Schedule.

(1) The room and board fee charged to participants of the ~~jail~~ work release program shall be set at a maximum of ten dollars, twenty-five dollars per day, subject to a variance as provided in 4.53.030.

(2) The supervision and monitoring fee charged to participants of the home detention program shall be set at a maximum of fifteen dollars per day, subject to a variance as provided in 4.53.030.

(3) The supervision and monitoring fee charged to participants of the community service program shall be ten dollars per month, subject to a variance as provided in 4.53.030 and RCW 9.94.135 effective July 28, 1991.

Section 3. SCC 4.53.040, adopted by Ordinance 82-081 SS2 (part), on August 24, 1982, is amended to read as follows:

4.53.040 Use of Funds. The funds received as daily payment from the Work Release, Home Detention or Community Service Work Crew participants shall be deposited in a bank trust account. Before the third work day of each month, a check reflecting the total receipts for the previous month shall be delivered to the office of the Snohomish County Treasurer and shall be placed into the general fund. These funds will defray the costs resulting from the operation of the Work Release these programs. (Ord. 82-081 SS2 (part), adopted August 24, 1982.)
