AN ORDINANCE AMENDING SNOHOMISH COUNTY CODE
CHAPTER 2.12, RELATING TO JUSTICE COURT BOUNDARIES

BE IT ORDAINED:

Section 1. Snohomish County Code Section 2.12.020 last amended by Ordinance No. 91-091 on July 10, 1991 is hereby amended to read:

2.12.020 Cascade District boundaries.
