ORDINANCE NO. 94 - *043*
AMENDING THE SNOHOMISH COUNTY CODE,
TITLE 4, CHAPTER 4.90, RELATING TO USER FEES FOR
THE COURTHOUSE FACILITATOR PROGRAM

BE IT ORDAINED:

Section 1. That Snohomish County Code, Title 4, Chapter 4.90 established by Ordinance Number 93-109, adopted October 13, 1993, is amended to read:

Chapter 4.90
Courthouse Facilitator Program Surcharge *and User Fees*

- 4.90.010 Assessment of Surcharge *and User Fees* Authorized
- 4.90.020 Applicability
- 4.90.030 Collection of Surcharge *and User Fees*
- 4.90.040 Surcharge *and User Fees* to be Deposited in Separate Account

4.90.010 Assessment of Surcharge *and User Fees* Authorized. The Snohomish County Clerk, ex-Officio Clerk of the Superior Court, is hereby authorized to assess a ten dollar (\$10.00) surcharge on all superior court cases filed under Title 26 RCW; *and to establish reasonable fees for services of the courthouse facilitator program, including but not limited to charges for instructional classes.*

4.90.020 Applicability. All parties filing superior court cases under Title 26 RCW are responsible for paying the surcharge at the time a case is initiated, unless the surcharge is waived specifically by the superior court, or the surcharge is ordered by the superior court to be paid in another manner. *All parties using courthouse facilitator services for which fees have been established are responsible for paying these fees in advance, unless said fees are waived by the superior court or ordered to be paid in another manner.*

4.90.030 Collection of surcharge *and user fees.* The Clerk of the Superior Court shall collect the surcharge *and user fees* in the same manner that other fees and charges are collected.

4.90.040 Surcharge and user fees to be deposited in separate account. The surcharge and user fees so collected shall be placed monthly in a separate account to be used to pay expenses of the courthouse facilitator program.
