AMENDING TITLE 2.12 OF THE SNOHOMISH COUNTY CODE
RELATING TO THE PRECINCTS WITHIN DISTRICT COURT BOUNDARIES

BE IT ORDAINED:

Section 1. Snohomish County Code Section 2.12.020, last amended by Ordinance No. 93-047 on June 30, 1993, is amended to read:

2.12.020 Cascade District boundaries.

(1) The justice court district in north Snohomish county, known as "Cascade District," shall be revised to include all the land lying within the following voting precincts. A complete legal description of the precinct boundaries is on file with the county auditor.
