BE IT ORDAINED:

Section 1. That SCC, Title 23, subsection 23.36.030(3), last amended by amended Ord. No. 93-039 adopted August 4, 1993, is amended to read:

23.36.030 Environmental policies. Snohomish County designates and adopts by reference the following policies as the basis for the county's exercise of authority pursuant to this chapter:

...

(3) The county adopts by reference the policies contained in the following county ordinances, resolutions and plans as currently adopted or as hereafter amended:

- (a) Snohomish County Comprehensive Plan and Subarea Plans (See also subsection (3)(t))
- (b) Shoreline Management Master Program (Title 21)
- (c) Agricultural Preservation Plan
- (d) Zoning Code (Title 18)
- (e) Drainage Ordinance (Title 24)
- (f) Road Ordinance (Title 26B)
- (g) Flood Hazard Ordinance (Title 27)
- (h) Noise Ordinance (Title 10.01)
- (i) Subdivision Ordinance (Title 19)
- (j) Short Subdivision Ordinance (Title 20)
- (k) SR 527 Traffic Mitigation Policy
- (l) Snohomish County Comprehensive Park and Recreation Plan
- (m) School Impact Mitigation Ordinance (Title 26C)
- (n) Park and Recreation Facility Impact Mitigation Ordinance (Title 26A)
- (o) Interim Ground Water Protection Ordinance (Ordinance No. 92-017)
- (p) Interim Forest Land Conservation Plan (Motion No. 92-283)
- (q) Interim Development Regulations to Conserve Forest Lands (Ordinance No. 92-101)
- (r) Interim Agricultural Conservation Plan (Motion No. 93-145)
- (s) Interim Agricultural Land Regulations to Conserve Agricultural Lands (Ordinance No. 93-038)
- (t) Critical Areas Regulation Ordinance (Title 32.10). The provisions of this ordinance supercede the policies contained in the Snohomish County comprehensive plan and subarea plans which apply to development activities affecting critical areas.
