AN ORDINANCE OF THE SNOHOMISH COUNTY COUNCIL AUTHORIZING A  
FEE ASSESSMENT ON ALL OFFENDER LEGAL FINANCIAL OBLIGATIONS  
WHERE RESTITUTION IS ORDERED AND PAID THROUGH THE SUPERIOR  
COURT REGISTRY AND ADDING  
A NEW CHAPTER TO THE SNOHOMISH COUNTY CODE  
CHAPTER 4.94  
SUPERIOR COURT FEES FOR SETTING UP AND MONITORING OFFENDER  
RESTITUTION OBLIGATIONS

BE IT ORDAINED:

Section 1. A new chapter is added to Title 4 of the Snohomish County Code to read:

Chapter 4.94  
SUPERIOR COURT FEES FOR SETTING UP AND MONITORING OFFENDER  
RESTITUTION OBLIGATIONS

Sections:

- 4.94.010 Set-up Fee Established
- 4.94.020 Applicability
- 4.94.030 Fee Collection
- 4.94.040 Fees to be Deposited in Current Expense Fund

Section 2. A new section is added to Chapter 4.94 of the Snohomish County Code to read:

4.94.010 Set-up Fee Established. Superior Court fees for setting up and monitoring offender restitution obligations follows:

|  |         |
|--|---------|
| Restitution in an amount Less than \$1,000.....      | \$15.00 |
| Restitution in an amount of \$1,000 to \$10,000..... | 25.00   |
| Restitution over \$10,000.....                       | 50.00   |

This fee is for the sole purpose of setting up and maintaining the payment record and accounts, therefore, it shall be the Clerk's first priority in collecting over other assessed obligations.

Section 3. A new section is added to Chapter 4.94 of the Snohomish County Code to read:

4.94.020 Applicability. All offenders making payments of court ordered restitution shall be responsible for said set up fee, except those parties where said fee has been waived by court order.

Section 4. A new section is added to Chapter 4.94 of the Snohomish County Code to read:

4.94.030 Fee Collection. The clerk of superior court shall adopt appropriate procedure and policies for the collection of said fee.

Section 5. A new section is added to Chapter 4.94 of the Snohomish County Code to read:

4.94.040 Fees to be deposited in current expense fund. All fees so collected shall be placed in the current expense fund of Snohomish County on a monthly basis.
